### Foreign currency

Online foreign currency exchange via the mobile app.

Purchase of foreign currency on the Interbank Foreign Exchange Market  
0.5% min UAH 100

Sale/exchange of foreign currency on the Interbank Foreign Exchange Market  
0.2%

Term deposit at the expense of purchased foreign currency

Amount – from 500 EUR/USD, term – 3 months (93 days), rate – 0.01% per annum, monthly interest payment, without the right of premature termination
